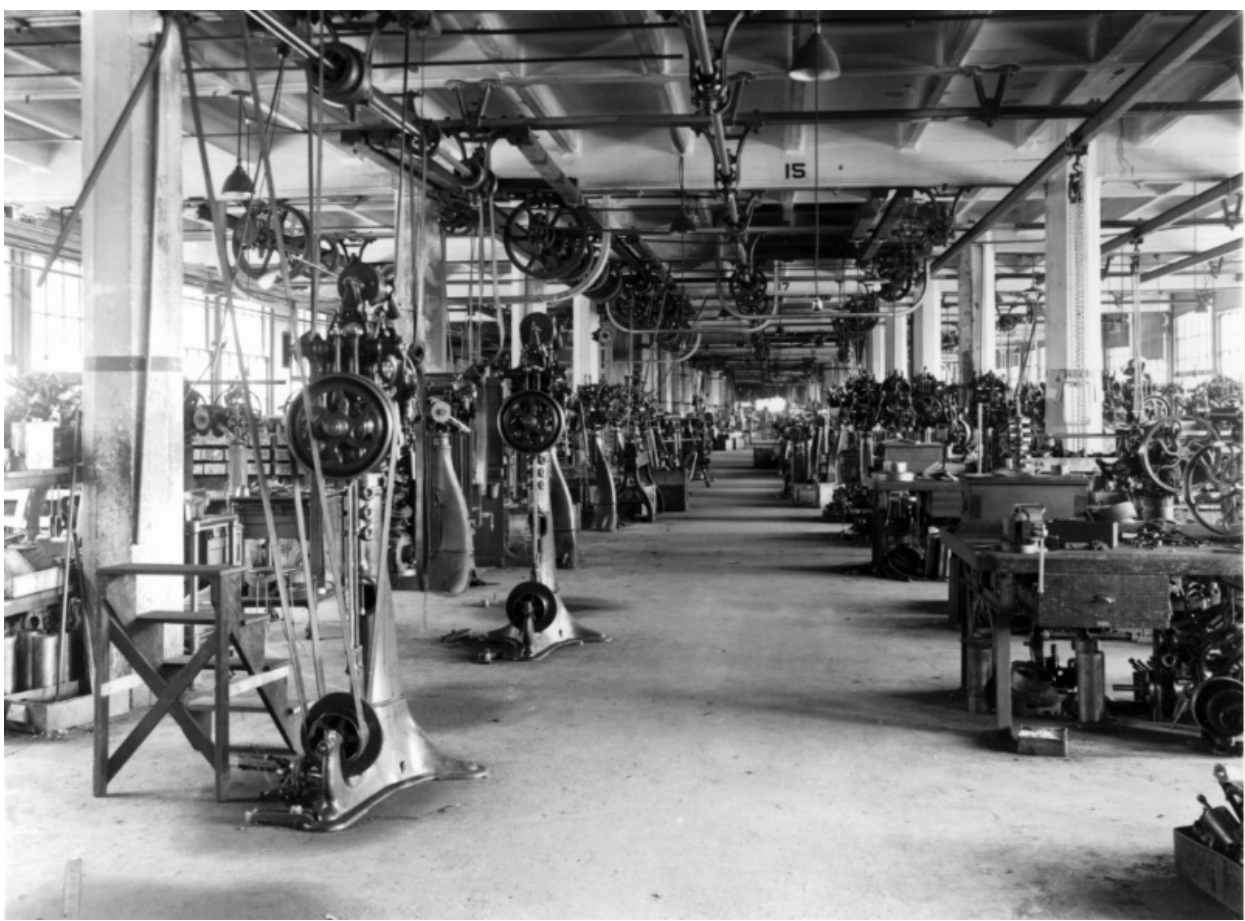

## Shoe Snippets

*Fun facts about the historic Cummings Center site, formerly known as "The Shoe."*





The Shoe designed and manufactured nearly all the major parts in its shoe machinery, effectively dominating the world market for shoe-making equipment. It created more than 300 different machines that could be purchased or leased, depending on an individual company's needs. The Shoe's research division reportedly registered more than 9,000 U.S. patents.
