Fire Alarm Safety: In the event a fire alarm sounds, evacuate the building immediately. Exit through the closest stairway and proceed as quickly as possible while maintaining the safety of others. After exiting, please remain a safe distance from the building. This will allow everyone to evacuate without hindering the efforts of the fire officials. Should a fire or any other building evacuation emergency occur, wait for police or fire officials to announce that it is safe before re-entering a building. In the event that you accidentally trigger an alarm, please remain present and communicate what occurred to the fire department.




