



Employer Action Item



Effective July 31, temporary COVID-19 accommodations enabling employers to review I-9 documentation remotely will expire. At that time, employers must resume physically inspecting the documentation requested in Section 2 of Form I-9 for all new employees. Additionally, by August 30,

employers must complete an in-person review for all employees who previously submitted their I-9 documents virtually. Learn how these changes may affect your business <u>via this brief</u>, informative report published by <u>McLane Middleton</u>.

Get Your Bills on Time: Please configure your email to *allow all* messages from <u>billing@cummings.com</u> in order to prevent bills and other important communications from our Accounting Department from being misdirected to SPAM.



Place a Service Call Online: Cummings provides services Monday through Friday maintenance (except holidays) from 7:00 AM through 4:00 PM for all building-standard equipment. Clients may service online request calls bv visiting cummings.com/service_call/beverly or using Cummings' Service Call App. The online system not only offers a quick and easy way to report a

maintenance issue but also helps to expedite service.

If preferred, you may still place a service call by phone. Service requests

are dispatched in the order received and generally responded to before the end of the next business day.

As a reminder, local police or fire departments should always be notified first in the event of a life safety emergency (e.g., fire, accident, burglary). Similarly, suspected gas leaks should be reported directly to the appropriate gas company.
